AN INVITATION TO JOIN A 40-DAY DEVOTION

We all agreed that it would be appropriate to offer a global devotional condition, and the dates have been decided as above.

A. Title: Worldwide Blessed Families 40-Day Period of Special Devotions

B. Participants: Blessed families, members, and ambassadors for peace

C. Period: 40 days - **July 22 to August 30, 2026**

D. Methods of offering devotions:

1. Prayer (detailed prayer points to follow)
2. Hoondokhae: Daily reading, (suggested materials to follow)
3. Relay fasting: 40-day relay fasting (one-day or breakfast fasting) by church or by organization
