Special counsel case on religion-politics collusion and political funds (2022) Dr. Han was indicted over alleged payments to figures connected to the Yoon Suk-yeol administration, on charges including violating the Political Funds Act, violating the Improper Solicitation and Graft Act, and occupational embezzlement. On July 10, 2026, the special counsel requested a 13-year prison sentence, and the trial concluded. The first-instance verdict is scheduled for August 31. Her detention has been suspended on health grounds, currently extended through September 2.

Hak Ja Han President, No Indictment Due to Insufficient Evidence

On August 11, the joint prosecution-police investigation headquarters announced the disposition results regarding suspicions of political fund donations made through organizations affiliated with the World Peace and Unification Family Federation.

On August 10, three individuals, including former World Headquarters Director Yoon Young-ho, were indicted without detention on suspicions of violating the Political Funds Act and embezzlement in the course of business duties.

Six district leaders were subject to summary indictment.

This case pertains to donations allegedly made to 132 politicians from September 2019 to January 2025.

For President Hak Ja Han and former Chief of Staff Secretary Jeong Won-ju, it was determined that there was insufficient evidence of direct involvement, leading to a decision of non-referral and return of records, thereby concluding the investigation.

During the investigation process, house searches were conducted at places such as the Cheon Seong Gyeong Palace, approximately 480 financial accounts were tracked, and 82 individuals involved in the case were interviewed.

President Hak Ja Han is currently indicted in a separate special prosecutor case related to suspicions from 2022, but in this case, it has been officially determined that there is insufficient evidence of direct involvement.

2. Political donations to 132 politicians (2019–2025)

A joint police-prosecution investigation resulted in the indictment of former officials without detention. For Dr. Han, the task force found insufficient evidence of direct involvement and did not charge her.

The decision not to charge applies only to the second case. It has no direct bearing on the first case, which is already indicted and before the court.

The two cases were handled by different investigative bodies and cover different time periods.

This summary is based on public reporting. Circumstances may change with future rulings.
